



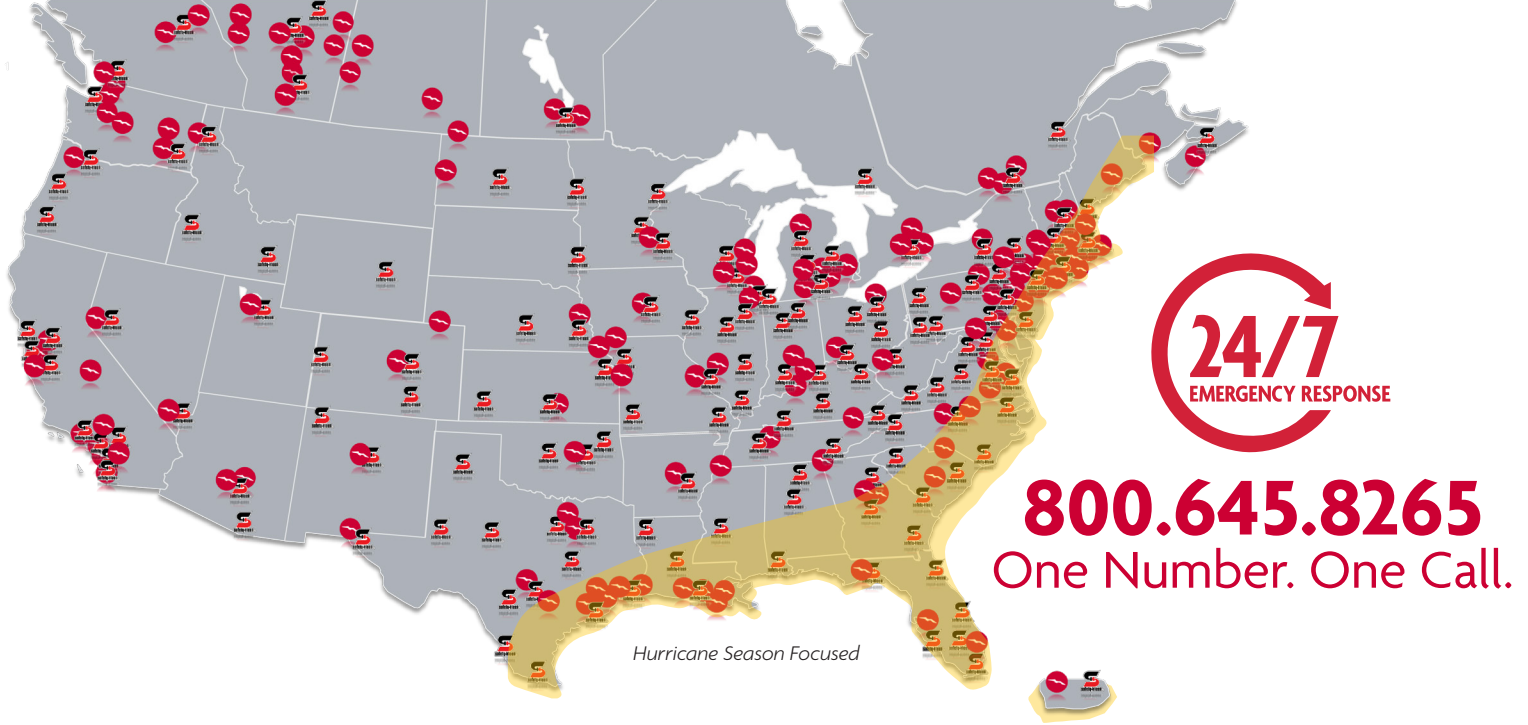

As a classified OSRO in the River/Canal, Inland, and Great Lakes Operating Environments, Clean Harbors is the go-to provider for any responses in inland environments.



Clean Harbors is one of only a handful of OSRO's to also be classified by the USCG as qualified to respond to Non-Floating Oil spills.
